City Council Staff Report

October 19, 2021

AGENDA ITEM:

Resolution of the City Council of the City of National City adopting a 1st phase spending plan for a portion of the American Rescue Plan Act (ARPA) funding and approving appropriations in accordance with the plan.

EXPLANATION:

In March 2021, a \$1.9 trillion economic stimulus bill titled the American Rescue Plan Act of 2021 (ARPA) was enacted by the federal government. Of the \$1.9 trillion, \$350 billion was allocated for state, local, territorial, and Tribal governments to respond to the COVID-19 emergency and promote economic growth. The Federal Government refers to this portion of the stimulus bill as the Coronavirus State and Local Fiscal Recovery Funds. Of the \$350 billion, the City of National City is receiving \$18,010,907. The City has received half of the funding, \$9,005,453.50, and will receive the other half around June 2022. The City is required to submit quarterly expenditure reports to Treasury and annual revenue loss reports. All expenditures need to be incurred by December 31, 2024 and paid by December 31, 2026.

The U.S. Treasury issued an Interim Final Rule with guidance on the funding allocation methodology, distribution process, and reporting requirements as well as Frequently Asked Questions to assist jurisdictions in interpreting the policy language. The Treasury accepted comments on the Interim Final Rule until July 16, 2021, and anticipates issuing the Final Rule that will govern the program in late fall 2021.

The four funding objectives of the State and Local Fiscal Recovery Funds are:

- Support urgent COVID-19 response efforts to continue to decrease spread of the virus and bring the pandemic under control.
- 2. Replace lost public sector revenue to provide government services to the extent of the reduction in revenue experienced due to the pandemic.
- 3. Respond to the negative economic impacts of the pandemic, including assistance to households, small businesses, and non-profits, and aid to impacted industries.
- 4. Address systemic public health and economic challenges that have contributed to the unequal impact of the pandemic on certain populations.

At the August 3, 2021 City Council meeting, staff presented an overview of the eligible spending categories and some potential expenditures that meet ARPA eligibility. At that time, City Council

instructed staff to return with a specific spending plan during a special workshop once the U.S. Treasury Department had issued the Final Rule.

The U.S. Treasury Department has exceeded the 60-day period during which federal agencies are supposed to publish a final rule after public comment ends. When staff inquired about when we can expect a Final Rule on ARPA, the Treasury Department stated it will not be published until late fall and directed public agencies to proceed with spending the funds under the guidance detailed in the interim final rule. Therefore, staff is recommending a specific expenditure plan for a little over half (\$9,455,000) of the City's ARPA allocation that complies with the existing Treasury rule. The remaining allocation (\$8,555,907) will be revisited in February/March of 2022 as part of the fiscal year 2022-2023 budget development, at which time the final guidance from the U.S. Treasury Department will be available.

The table below lists each of the proposed expenditures for consideration this evening, followed by narrative information on each project.

General Fund Expenditure Offsets. Under the existing U.S. Treasury Department rule revenue loss calculation, National City has no revenue loss in relation to funding objective number two. Since the City is unable to use the flexibility of the revenue loss replacement category at this point in time, staff reviewed the General Fund Fiscal Year (FY) 2021-2022 adopted budget for projects and programs that were already planned and budgeted, but are eligible to be paid with ARPA funds. By shifting those expenditures from the General Fund to ARPA funding, the General Fund savings can reduce the anticipated budget deficit. The following General Fund budget expenditures are eligible to be funded with ARPA.

- Personnel expenditures to bring staffing back to pre-pandemic levels across all departments
- Parks & recreation maintenance due to increased demand on outdoor facilities and promoting healthy childhood environments
- Homeless services, including the Homeless Outreach Team in the Police Department and the homeless services provided by the Neighborhood Services Department
- Library digital literacy and youth focused programming
- Storm drain projects
- Chamber of Commerce contribution for COVID-19 economic recovery work

These expenditures total approximately \$2,060,000 for FY 2022. Looking forward, everything except the Chamber of Commerce contribution are on-going costs, therefore the ARPA funds could be used for \$2,010,000 in both FY 2023 and FY 2024, for a total General Fund offset of \$6,080,000 over three fiscal years. The expenditure descriptions, ARPA eligibility category, and amount by fiscal year are detailed in attachment A.

Premium Pay to City Employees. As essential workers, City employees can be provided premium pay to further compensate for the increased risk of COVID-19 exposure while on the job. U.S. Treasury rules limit the premium pay to essential workers who worked in person during the pandemic and who make less than 150% of the average area income. City Council has expressed an interest in utilizing a portion of ARPA funding to provide premium pay stipends to eligible employees. The details of the stipend payments are under negotiation with each represented group.

Deferred Maintenance Needs. The next two projects are facility deferred maintenance projects that were discussed as part of the fiscal year 2021-2022 CIP Budget.

Replaster Las Palmas Pool. The pool was originally commissioned in 1958 and requires replastering every 10-15 years. The pool was last replastered in 2007, 15 years ago, and is in immediate need of replacement in order to continue pool operations. If the funding for this project is allocated tonight, the project is targeted to occur this winter. The pool will be closed for 4-6 months to complete the work.

Las Palmas Pool Deck Rehab. Similar to the condition of the plaster at the pool, the pool decking (concrete flatwork) is also in need of immediate replacement. Staff has already repeatedly patched and repaired the decking. Images of the pool's current condition are included in the presentation of the agenda item. Included in the deck rehab, a new outdoor area will be designed and designated for event rentals. It will be a covered area featuring tables, seating, and a barbeque and will serve as an additional revenue generator for pool operations. If the funding for this project is allocated tonight, the project is targeted to occur this winter in combination with the replaster work described above.

CIP Design & Outreach. The following three items, for a total of \$225,000, represent the design and community outreach process for potential CIP projects that the remaining ARPA allocation could fund. These expenditures will provide the City the conceptual designs, cost estimates, and public feedback needed to prioritize future spending on eligible CIP projects.

Las Palmas Wellness Center Design. As discussed at the August 3, 2021 City Council meeting, the existing Las Palmas Pool locker rooms need to be updated and ADA upgrades completed for an estimated \$350,000. Instead of updating the existing outdated locker room building, the building could be demolished and multi-purpose facility built adjacent. The new facility would be multi-level and include lockers and activity/meeting rooms as the City's new Wellness Center. Preliminary concept designs of the Wellness Center and corresponding cost estimates for construction can be completed for \$100,000. If the funding for this project is allocated tonight, staff will engage the appropriate architectural professionals to have the conceptual designs ready for consideration as part of the strategic planning and CIP prioritization/second APRA allocation in February or March of 2022.

Kimball Park Master Plan. Kimball Park is a key community asset of National City with areas that could use enhancement and renovation. To revision the park, staff is requesting \$100,000

to fund a Kimball Park master plan that will provide direction for future park updates. Funding for the specific park updates identified in the plan can be considered for allocation within the remaining ARPA balance in early 2022.

Community Outreach. In an effort to elicit public input and encourage robust participation regarding the strategic planning and CIP prioritization including the Las Palmas Wellness Center Design and Kimball Park Master Plan, staff recommends setting aside \$25,000 to fund the collection and analysis of community input. This information will be gathered in a variety of forums, such as hosting at least two community engagement meetings, preparing a survey in English and Spanish, hosting booths at large community events (i.e., A Kimball Holiday), and contacting our local stakeholders (parents with children in local schools, seniors, etc.). It will be essential to utilize a range of outreach techniques to gather the widest possible participation from the public.

Other Potential Funding Sources. It is worth noting that there are at least two potential funding sources that may be awarded to the City for expenditures currently included in the ARPA spending plan. Specifically, the State of California may be providing \$2M to the City for Las Palmas Pool deferred maintenance projects and the City has a pending grant application submitted to the State of CA Coastal Conservancy for Prop 68 funding for Kimball Park. Neither of these funds have been secured. By next February/March when City Council will adopt a 2nd phase spending plan for the remaining balance of ARPA funds, the status of the other funding sources will be confirmed and tonight's 1st phase spending plan can be adjusted accordingly. Staff will also diligently pursue new funding sources that may be available through federal and/or state stimulus funds.

Staff Recommendation.

- 1) Adopt a resolution adopting an ARPA 1st phase spending plan for approximately half of the City's APRA funding.
- 2) Provide direction to staff on community engagement process for 2nd phase spending plan with remaining \$8.55M of ARPA funding.
 - a. Goal of the community engagement process is to provide City Council with public feedback on strategic planning and CIP prioritization.

WHEREAS, City staff is recommending a specific expenditure plan for a little over half (\$9,455,000) of the City's ARPA allocation that complies with the existing Treasury rule with the remaining allocation (\$8,555,907) to be revisited in February/March of 2022 as part of the Fiscal Year 2022-2023 budget development, at which time the final guidance from the U.S. Treasury Department will be available; and

WHEREAS, City staff is also asking for direction on community engagement process for the remaining \$8.55 million of ARPA funding.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF NATIONAL CITY, CALIFORNIA, DOES RESOLVE, DECLARE, DETERMINE, AND ORDER AS FOLLOWS:

Section 1: Authorize adopting a spending plan for a portion of the American Rescue Plan Act funding and approving appropriations in accordance with the plan.

Section 2: The City Clerk shall certify the passage and adoption of this Resolution and enter it into the book of original Resolution.
