**NOTICE:** The health and well-being of National City residents, visitors, and employees during the COVID-19 outbreak remains our top priority. **ORDER OF BUSINESS:** Public sessions of all Regular Meetings of the City Council / Community Development Commission - Housing Authority (hereafter referred to as Elected Body) begin at 6:00 p.m. on the first and third Tuesday of each month. Public Hearings begin at 6:00 p.m. unless otherwise noted. Closed Meetings begin in Open Session at 5:00 p.m. or such other time as noted, and after announcing closed session items, convenes into a Closed Meeting. If a workshop is scheduled, the subject and time of the workshop will appear on the agenda. The Mayor and Council members also sit as the Chairperson and Members of the Board of the Community Development Commission (CDC).

**REPORTS:** All open session agenda items and reports as well as all documents and writings distributed to the Elected Body less than 72 hours prior to the meeting, are available for review on the City's website at <u>www.nationalcityca.gov</u>. Regular Meetings of the Elected Body are webcast and archived on the City's website at <u>www.nationalcityca.gov</u>.

**PUBLIC COMMENTS:** There are multiple ways you can make sure your opinions are heard and considered by our City Council as outlined below:

Submit your public comment prior to the meeting: To submit a comment in writing, email <u>PublicComment@nationalcityca.gov</u>, provide the agenda item number and title of the item in the subject line of your email. Public comments or testimony is limited to up to three (3) minutes. If the comment is not related to a specific agenda item,

indicate General Public Comment in the subject line. All email comments received by 1:00 p.m. on the day of the meeting will be emailed to the City Council Members and made a part of the official record.

**Register online and participate in live public comment during the meeting**: To provide live public comment during the meeting, you must pre-register on the City's website at <u>https://www.nationalcityca.gov/publiccomment</u> by 1:00 p.m. on the day of the regular meeting to join the City Council Meeting.

\*\*\*Please note that you do not need to pre-register to watch the meeting online, but you must pre-register if you wish to speak.

Once registered, you will receive an email with a link from Zoom to join the live meeting. You can participate by phone or by computer. Please allow yourself time to log into Zoom before the start of the meeting to ensure you do not encounter any last-minute technical difficulties.

\*\*\*Please note that members of the public will not be shown on video; they will be able to watch and listen and speak when called upon. Public microphones will be muted until it is your turn to comment.

Each speaker is allowed up to three (3) minutes to address the City Council. Please be aware that the Mayor may limit the comments' length due to the number of persons wishing to speak or if comments become repetitious or unrelated.

All comments are subject to the same rules as would otherwise govern speaker comments at the meeting. Speakers are asked to be respectful and courteous. Please address your comments to the City Council as a whole and avoid personal attacks against members of the public, City Council, and city staff.

**INTERPRETATION SERVICES:** <u>To use the Zoom interpretation feature you must first</u> <u>Pre-Register on Zoom</u>. If you are joining using the Zoom mobile app (cell phone, tablet, etc.), please press the ellipsis (...), then Interpretation, and then choose your language.

**WRITTEN AGENDA:** With limited exceptions, the Elected Body may take action only upon items appearing on the written agenda. Items not appearing on the agenda must be brought back on a subsequent agenda unless they are of a demonstrated emergency or urgent nature, and the need to take action on such items arose after the agenda was posted.

**CONSENT CALENDAR:** Consent calendar items involve matters which are of a routine or noncontroversial nature. All consent items are adopted by approval of a single motion by the City Council. Prior to such approval, any item may be removed from the consent portion of the agenda and separately considered, upon request of a Councilmember, a staff member, or a member of the public.

#### Background

On December 21, 2021, the City Council voted to change the way the City Councilmembers are elected, transitioning to district based elections for the four City Councilmember seats. The Mayor would remain elected at-large. This transition requires that the City create districts and adopt a boundary map.

On Thursday, February 3, 2022, the City Council conducted the first required Public Hearing to provide information to the public on the districting process, the permissible criteria to be considered to draw district boundaries, and the process on how to submit draft maps for consideration, as well as to receive public comment. One verbal comment was received from Ken Seaton-Msemaji and three (3) written comments received from Rocina Lizarraga, Joan Rincon, and Evangline Meneses. In attendance were consultants from Redistricting Insights, SVPR Communications, and City staff. One member of the public registered for the meeting and attended via Zoom.

On Saturday, February 5, 2022, Community Workshop was held to provide information to the public on the process of creating districts for elections and the process on how to submit draft maps for consideration, as well as to receive public comment. The demographer provided an explanation on the districting process, and provided mapping tool training. Four (4) verbal comments were received from Cynthia Suero-Gabler, Gloria Cooper, Ken Seaton-Msemaji, and Mitz Lee. In addition, one (1) written comment was received from Thelma De Castro. In attendance were consultants from Redistricting Insights, SVPR Communications, and City staff. Five (5) members of the public registered for the meeting and attended via Zoom.

On Tuesday, February 22, 2022, the City Council conducted the second required Public Hearing accepting maps submitted for consideration. The demographer introduces the five (5) maps submitted and the public provided and presented a PowerPoint Presentation on the process. Cynthia Suero-Gabler representing the Asian Pacific American Coalition also provided a PowerPoint Presentation. Eight (8) verbal comments were received from Kandi Custodio-Tan, Alicia Sanchez, Monserrat Hernandez, Margarita Moreno, Silvia Calzada, JoAnn Fields, Ditas Yamane, and Ken Seato-Msemaji. In addition, nineteen (19) written comments were received from Kirin Macapugay, Thelma Virata de Castro, DJ Kuttin Kandi, Tony Olaes, Ted Godshalk, Nicole, Shawn Chua, Mark Leo, Czeska Cabuhat, Khue Tran, Marianne Delatorre, Andrew Amorao, Kristina Mananquil, Jose Ceja, Myleen Abuan, Alicia Ricafrente, Wendy Aragon-Mills, Salvador B. Flor, and Debbie Discar-Espe. In attendance were consultants from Redistricting Insights, SVPR Communications and City staff. Fifteen (15) members of the public registered for the meeting and attended via Zoom.

Twenty-Eight signed maps were received in support of the Asian Pacific American Coalition Proposed Map #1.

The four (4) districts must be drawn using the 2020 census data and in compliance with the FAIR MAPS Act (Act), which was adopted by the California Legislature as Assembly Bill 849 and took effect January 1, 2020.

On Saturday, March 5, 2022, the City Council conducted the third required Public Hearing accepting maps for consideration. The demographer provided eight (8) maps submitted and the public provided and presented a PowerPoint Presentation. Mark Lea representing the South Bay Collective for Fair Representation for National City Districting. Twelve (12) verbal comments were received from Myleen Abuan, Kandi Custodio-Tan, Jose Franco-Garcia, Monserrat Hernandez, Alicia Sanchez, Silvia Calzada, Marianne Delatorre, Kristina Piggy, Pebblz Luv, Mae Case, and JoAnn Fields. In addition, twenty-four (24) written comments were received from Alfredo Leano, Alicia Ricafrente, Amy Castañeda, Andrew Amorao, Angela Subido, Charlene Villena, Cynthia "CK" Suero-Gabler, Neighborhood Voices of San Diego, Diana Laranang, Dr. DJ Kuttin Kandi, Ellen Nash, H. Bradley Bang, List of Names in Support of APAC Map submittal, Kathy Vilaysith, Kylie Taitano, Lorilee San Agustin, Mitz Lee, Myrna TF Reyes, Nao Kabashima, Neal Ortiguerra, Ron T. Cho, Shawn Chua, and List of Names in Support of APAC Map Submittal – Voting Rights Act Now. (Lists of names are available in the City Clerk's office and on the City website).

Under the Act, the maps are drawn and adopt boundaries using the following criteria in the listed order of priority:

- 1. Comply with the federal requirements of equal population and the Voting Rights Act.
- 2. Geographically contiguous
- Undivided neighborhoods and "communities of interest" (socio-economic geographic areas that should be kept together)
- 4. Easily identifiable boundaries
- 5. Compact (do not bypass one group of people to get a more distant group of people)
- 6. Shall not favor or discriminate against a political party.

On Tuesday, March 15, 2022, at a Special Meeting of the City Council consideration of the eight (8) final draft maps presented for consideration. The City Council adopted the public Submittal #4 as the final map for the by-district elections with a vote of 4-1, with Councilmember voting No.

Ten (10) verbal comments were received from Monserrat Hernandez, Alicia Sanchez, Myleen Abuan, Kandi Custodio-Tan, Jose Franco Garcia, Marianne Delatorre, Mae Case, Kristina Manaquil, Julio DeGuzman, and Joann Fields. In addition, twenty-six (26) written comments were received from Teddy Datuin, Stacey Uy, Cynthia Suero-Gabler, Femie Villaflores, Ken Seaton-Msemaji, Myrna TF. Reyes, Alfredo Leano, David Garcias, Joyce Ann Eclarino, Angelica Ramirez, Silvia Calzada, Joseph V. Mazares III, Eric of the Asian Solidarity Collective, Pebblz Luv, Dyno of the Asian Solidarity Collective, Ron Cho, Diana Go, Debbie Espe, Amy Castaneda, Aurora Soriano Cudal, Angela Subido, Jerry Cano, Karla Nava, Jose Lopez, Board of Directors – COPAO, and Mark Leo.

Present: Monday, March 21, 2022 at 3:00 p.m. – 1) Public Hearing to Consider District Elections and Numbering Districts Map; 2) Public Hearing to Conduct Random Drawing to Determine Sequence of District Elections; and 3) An Urgency Ordinance of the City Council of the City of National City, California, Establishing City Council Election District Boundaries, Sequencing Elections Within Those Boundaries, and Adding Chapter 2.77 ("By-District Elections") of Title 2 ("Administration") to the National City Municipal Code to Change the City's Electoral System from At-Large to By-District with Respect to Electing Members of the City Council.

At the conclusion of the March 15, 2022, public hearing the Council voted to direct staff to prepare an ordinance adopting the final map, the City's voting district map an eligible map submitted by the public referred to as Submittal #4. In addition, the City Council directed staff to return with a report to number the districts, and another report to provide guidelines for a random draw to determine the sequencing of the districts (evens/odds) will be placed on future elections in November 2022 and November 2024. The draw will be conducted during the Special City Council Meeting via Zoom by the Office of the City Clerk.

#### Community Outreach

The City has partnered with a consultant, Redistricting Insights, to utilize 2020 Federal Census data to determine district options for consideration. The City is working collaboratively with Falcon Strategies to engage the community and distribute information in multiple languages to ensure participation from all segments of the community.

To date outreach has included:

- 1. City Social Media (Facebook, Instagram, Twitter) and the City website (District Elections) page.
- 2. The City website page and social media includes translations of all documents in Spanish, and Tagalog.
- 3. Legal Noticing (English, Spanish, Tagalog) in The Star News, El Latino, and the Filipino Press. Also available on the City Bulletin Boards at City Hall and the City website Districting page.
- 4. Interviews with the City Clerk on Telemundo TV, NBC and CBS
- 5. Kiosks set up at the Library to assist with online mapping tool
- 6. Assistance at Library with the paper map drawing process
- 7. Livestreaming of public meetings on the City website and videos posted for future viewing.

#### November 2022 Elections

The City Council has determined that transitioning to by-district elections would be in the best interest of the City. This will be effective once an Urgency Ordinance is adopted and the Municipal Code changed to reflect the new process. Pursuant to California Government Code Section 34886, Councilmembers and future candidates would be elected to represent a district, and must reside in that district and be a registered voter in that district. The Mayor would remain at-large representing the City as a whole.

The first by-district election would occur in November 2022 with the current terms of Mayor Sotelo-Solis, Councilmember Morrison, and Councilmember Rios ending. They may be considered for re-election depending on the final map adopted, which office they choose to pursue and the location of their residence.

For those Councilmembers currently in office at the time of the Ordinance codification, they shall continue in office until the expiration of the full term to which they were elected and until a successor is qualified. At the end of the term, each Councilmember thereafter, shall be elected on a by-district basis.

#### **Recommendation**

It is recommended that the City Council assign numbers to districts 1-4 in a clockwise direction on the Final District Map.


Final Map Proposal (Public Submission 4) Numbering Scenarios

#### Staff Recommendation:

Approve An Urgency Ordinance Of The City Council Of The City Of National City, California, Establishing City Council Election District Boundaries, Sequencing Elections Within Those Boundaries, And Adding Chapter 2.77 ("By-District Elections") Of Title 2 ("Administration") To The National City Municipal Code To Change The City's Electoral System From At-Large To By-District With Respect To Electing Members Of The City Council.

#### **Background:**

On November 8, 2021, the City of National City received a letter via certified mail from attorney Audie J. de Castro of de Castro, P.C. claiming to represent members of the City's Filipino/API community. The letter contains unsubstantiated allegations that the City's at-large elections system prevents members of National City's Filipino/API community from electing their preferred candidate(s) and violates the California Voting Rights Act ("CVRA"). The letter demands that the City transition from an at-large to a by-district election system to remedy this alleged violation.

#### **Resolution of Intention to Transition to Districts:**

Unlike the Federal Voting Rights Act, the CVRA makes it easier to challenge a city's electoral system if there is any evidence of racially polarized voting. Due to the highly technical nature of such litigation, the cost of defending a challenge under the CVRA can exceed several hundred thousand dollars. To

date, no City has successfully defended against a CVRA lawsuit. A loss bears the additional risk of a potential award of attorneys' fees to plaintiffs.

In 2014, the State Legislature adopted safe harbor provisions to provide some relief to cities facing expensive CVRA litigation. Elections Code section 10010 states that a potential litigant may not commence an action under the CVRA within 45 days of the City's receipt of the written notice. (Elec. Code\$10010(e)(2).) During that 45-day period, the City "may pass a resolution outlining its intention to transition from at-large to district-based elections, specific steps it will undertake to facilitate this transition, and an estimated timeframe for doing so." (Elec. Code\$10010(e)(3)(A).)

On December 21, 2021, the City Council approved Resolution No. 2021- 201, declaring its intent to transition from at-large to by-district elections under the safe harbor provisions of Elections Code section 10010. The City contracted with Redistricting Insights, Inc. to draw draft election district maps for the City Council's consideration and to make a map drawing software available to its residents. The City contracted with Falcon Strategies LLC to assist in its public outreach efforts and encourage residents' participation in the process.

#### **Public Hearings and Maps:**

The City held the statutorily required number of public hearings and workshops. Before drawing draft maps of the proposed boundaries of the districts, the City held public hearings on February 3, 2022 and February 22, 2022 and a community workshop on February 5, 2022, to invite the public to provide input regarding the composition of the districts and communities of interest. After the draft maps were drawn, the City held additional public hearings on March 5, March 15, and March 21, 2022, to invite the public to provide input regarding the draft maps, the district's numbering and the proposed sequence of elections.

The deadline to adopt a draft map is 90 days from the December 21, 2021 adoption of the Resolution of Intention. The 90 days expires on March 21, 2022. In total, the City received thirteen (13) maps — ten (10) were drawn by members of the public and three (3) were drawn by the City's demographer. At its March 5, 2022 special meeting, the City Council narrowed its consideration of draft maps to Public Submission 1, Public Submission 1 (adjusted) and Public Submission 4. At its March 15, 2022, special meeting, the City Council adopted Public Submission 4.

At its March 21, 2022 special meeting, the City Council must adopt an ordinance approving a draft map and a method to sequence elections for the approved map. Included as Attachments A-1, A-2, A-3, and A-4 is the adopted map with the potential district numbering and election sequencing.

Included as Attachment B is Urgency Ordinance. An urgency ordinance is necessary given the 90 day time limit to transition to by-district elections under the safe harbor provisions and the potential exposure to litigation and attorneys' fees associated with adopting a map after March 21, 2022. Unlike a regular ordinance, an urgency ordinance can be introduced and adopted after first reading and takes effect immediately.

Upon adoption, the City must submit a copy of the Urgency Ordinance and the demographer's related shape files to the San Diego County Registrar of Voters by April 17, 2022. The adopted election district map will be used for the November 2022 general municipal election.

#### **UREGENCY ORDINANCE NO. 2022 - 2497**

AN URGENCY ORDINANCE OF THE CITY COUNCIL OF THE CITY OF NATIONAL CITY, CALIFORNIA, ESTABLISHING CITY COUNCIL ELECTION DISTRICT BOUNDARIES, SEQUENCING ELECTIONS WITHIN THOSE BOUNDARIES, AND ADDING CHAPTER 2.77 ("BY-DISTRICT ELECTIONS") OF TITLE 2 ("ADMINISTRATION") TO THE NATIONAL CITY MUNICIPAL CODE TO CHANGE THE CITY'S ELECTORAL SYSTEM FROM AT-LARGE TO BY-DISTRICT WITH RESPECT TO ELECTING MEMBERS OF THE CITY COUNCIL

#### CITY ATTORNEY SUMMARY This Ordinance changing the City's Electoral System from At-Large to By-District with Respect to Electing Members of the City Council

WHEREAS, the Mayor and four members of the City Council of the City of National City ("City") are currently elected in "at-large" elections, in which the Mayor and each City Councilmember are elected by the registered voters of the entire City; and

WHEREAS, Government Code section 34886, in certain circumstances, authorizes the legislative body of a city of any population to adopt an ordinance to change its method of election from an "at-large" system to a "by-district" system in which each Councilmember is elected only by the voters in the district in which the Councilmember resides; and

WHEREAS, the City received a letter dated November 8, 2021 containing unsubstantiated allegations that the City's at-large electoral system prevents members of National City's Filipino/API community from electing their preferred candidate and violates the California Voting Rights Act ("CVRA") and threatening litigation if the City declined to adopt a district-based electoral system; and

WHEREAS, the City Attorney has advised that given the CVRA's elimination of two elements of the U.S. Supreme Court's requirements to establish a federal Voting Rights Act challenge under *Thornburg v. Gingles* (1986) 478 U.S. 30, a CVRA challenge is more easily made on the basis of an argument that "racially polarized voting" exists, regardless of whether racial minorities have successfully elected preferred candidates in the past under an at-large electoral system or whether there is an absence of historical racial discrimination in the electoral system based on the totality of the circumstances; and

WHEREAS, the cost of defending a challenge under the CVRA can exceed several hundred thousand dollars, no City has ever prevailed to date in defending a CVRA lawsuit challenging at-large electoral systems, and the risk of losing such a challenge includes the possible award of attorneys' fees to the plaintiffs by a court; and

WHEREAS, the City Council has concluded, on the advice of the City Attorney, that the public interest would be better served by considering a transition to a district-based electoral system pursuant to the "safe harbor" provisions of Elections Code section 10010; and

WHEREAS, pursuant to Elections Code Section 10010, Subdivision (e)(3)(A), the City Council adopted Resolution No. 2021-201 on December 21, 2021, declaring its intent to transition from an at-large to a district-based elections system; and

WHEREAS, the City contracted with Redistricting Insights, Inc. to draw draft election district maps for the City Council's consideration and to make a map drawing software available to its residents; and

WHEREAS, pursuant to Elections Code Section 10010, Subdivision (a)(1), the City contracted with Falcon Strategies LLC to publicize the public hearings and workshop by City website, City Social Media (Facebook, Twitter, Instagram), El Latino Newspaper, Filipino Press Newspaper, The Star News Newspaper, Posting Notices on City Hall Bulletin Boards located outside of City Hall, Radio Latina Interview of City Clerk, CBS Interview of City Clerk, Flyers, all in English, Spanish and Tagalog translations, and

WHEREAS, pursuant to Elections Code Section 10010, Subdivision (a)(1), before drawing draft maps of the proposed boundaries of the districts, the City held a public hearing on February 3, 2022, a community workshop on February 5, 2022, and a public hearing on February 22, 2022, to invite the public to provide input regarding the composition of the districts and communities of interest; and

WHEREAS, pursuant to Elections Code Section 10010, Subdivision (a)(2), after the draft maps were drawn, the City held public hearings on March 5, 2022, March 15, 2022, and March 21, 2022, to invite the public to provide input regarding the content of the draft maps and the proposed sequence of elections; and

WHEREAS, pursuant to Elections Code Section 10010, Subdivision (a)(2), the draft maps were published at least seven days before consideration at each public hearing; and

WHEREAS, the adoption of a district-based electoral system will not affect the terms of any sitting Councilmember or Mayor in office at the time of the adoption of an ordinance instituting a district-based voting system, each of whom will serve out his or her current term.

#### NOW, THEREFORE, BE IT RESOLVED THAT THE CITY COUNCIL OF THE CITY OF NATIONAL CITY, CALIFORNIA, DOES ORDAIN AS FOLLOWS:

**SECTION 1.** <u>Recitals</u>. The Recitals above are true and correct and incorporated herein by reference.

**SECTION 2.** <u>Addition</u>. Chapter 2.77 ("By-District Elections") of Title 2 ("Administration") is added to the National City Municipal Code to read as follows:

"Chapter 2.77 – By-District Elections

2.77.010 - Purpose.

The city council declares that this change in method of electing members of the city council is enacted in furtherance of the California Voting Rights Act of 2001.

2.77.020 – By-district elections

Commencing with the general election in November 2022, the four members of the city council shall be elected in the electoral districts established by 2.77.030 and subsequently reapportioned as provided by state law. Elections shall take place by-district as that term is defined in California Government Code Section 34871, meaning one member of the city council shall be elected from each district by the voters of that district alone.

2.77.030 – District boundaries.

Members of the city council shall be elected on a by-district basis from the four city council districts, the boundaries of which shall be identified in the City Council District Map.

2.77.040 - Term and election sequence.

Members of the city council shall be elected to a four year term in accordance with the election sequence identified in the City Council District Map.

2.77.050 – City council residency

Each member of or candidate for the city council must reside in the district and be a registered voter in the district in which he or she seeks election at the time nomination papers are issued pursuant to Government Code Section 34882 and Elections Code Section 10227. Any sitting city councilmember elected at-large may reside anywhere within the city during the pendency of his or her term.

2.77.060 - Termination of residency

Termination of residency in a district by a member of the city council elected by-district shall create a vacancy for that city council district unless a substitute residence within the district is immediately declared and established within thirty days after the termination of residency. In the event that a vacancy is created as a result of termination of residence as provided herein, such vacancy shall be filled pursuant to the provisions of the Elections Code.

2.77.090 - Mayor elected at-large

The office of the mayor shall be elected at-large under Government Code section 34900."

**SECTION 3.** <u>City Council District Map</u>. The City Clerk is directed to post a copy of the City Council District Map, included in this Ordinance as Attachment A, to the City's website.

**SECTION 4.** <u>District Boundaries</u>. The City Clerk is directed to request the demographer provide a list of the census tracts and/or blocks for each district and to attach that list to this Ordinance as Attachment B.

**SECTION 5.** <u>Controlling Authority</u>. If there is a discrepancy between the adopted map in Attachment A and the list in Attachment B, the adopted map in Attachment A shall control.

**SECTION 6.** <u>Urgency Findings</u>. This Ordinance should be passed immediately by a fourfifths vote under Government Code section 36934 as an "Urgency Ordinance" to accommodate the statutory timelines under Elections Code Section 10010 and to preserve the public fisc, peace, and welfare.

**SECTION 7.** <u>Transmittal to County</u>. The City Clerk is directed to provide a signed original of this Ordinance to the San Diego County Registrar of Voters.

**SECTION 8.** <u>Severability</u>. If any section, subsection, sentence, clause, phrase or portion of this Ordinance is for any reason held to be invalid or unconstitutional by the final decision of any court of competent jurisdiction, such decision shall not affect the validity of the remaining portions of this Ordinance.

**SECTION 9.** <u>Effective Date</u>. This Urgency Ordinance shall take effect immediately after its passage and adoption pursuant to California Government Code Section 36937; it or a summary of it shall be published once, with the names of the members of the City Council voting for and against the same in the Star News, a newspaper of general circulation published in the County of San Diego, California.
